THE BOOK HAD 78 COPIES IN PRINT AND WAS ABOUT TO BE ADVERTISED BY THE UK PUBLISHER WHEN EVEN THEY WENT BANKRUPT IT NEVER GOT ANY PUBLICITY WHATSOEVER, WHICH WAS THE PRINTERS RESPONSIBILITY AS PART OF THE AGREEMENT BETWEEN PARTIES. THE BOOK REFLECTS MAINLY ON THE STATE OF EUROPE'S NEWS, EVENTS, AND OTHER WORLD POLITICAL HAPPENINGS UP TO OCTOBER 1997. SINCE THEN THE EURO WAS FORMED AND NOW WE HAVE A NEW WAVE OF BANKRUPTCIES. EXCEPT THIS TIME IT INCLUDES SOVEREIGN COUNTRIES INSIDE THE EUROPEAN UNION MEMBERSHIP OF 27. BY READING THIS BOOK YOU WILL GET TO UNDERSTAND THE ROOT CAUSES OF WHY THIS HAS COME ABOUT. WHEN YOU TAKE INTO ACCOUNT THE SORRY STATE OF AFFAIRS THAT HAS OCCURRED SINCE 2007 YOU WILL CLEARLY UNDERSTAND SOMETHING REVOLUTIONARY HAS TO BE DONE ABOUT IT. THE POLITICAL PARTY SYSTEM OF GOVERNMENT METHODOLOGY IS ARCHAIC AND IS NO LONGER CAPABLE OF GOVERNING IN THE CONNECTED WORLD WE ARE LIVING IN TODAY.
